  - Meeting began with presentation from Timothy Wilder.

#### 5. Discussion Items

- o Transfort Route Improvement Project/TRIP (Wilder) Timothy Wilder presented about Transfort's TRIP project. TRIP investigates the changing needs, demographics, and housing so Transfort can be ahead of the curve. How can routes be aligned to serve residents more efficiently? TRIP will also consider land use, destinations, street design, and passenger type to create a tiered network of service: BRT, high-frequency, and low-frequency/shuttle services. Timothy discussed upcoming service changes. LCMC members discussed the northbound stop at the Fort Collins Senior Center, which will be moved to Drake and Shields. In the coming months, Transfort will finalize TRIP and implement short and long term goals and strategies.
- O Draft COLT Council Transit Workshop Agenda (Barnes) Christopher Barnes discussed what he will talk about at the July 26<sup>th</sup> Transit Workshop with the Loveland City Council. The Transit Workshop will address why transit is essential, how to create routes that remove cars, and how to get more people to ride transit. Can COLT become a part of the regional service? Loveland will continue to try to build a permanent transit center. Larimer County is an age-friendly community how does transit address changing community demographics? There is support in the community for improved transit the agency needs to harness it.

NFRMPO Non-Motorized Plan (Gordon) – Alex gave a quick presentation about the NFRMPO's Non-Motorized Plan. The Plan will update the 2013 Bike Plan and will add a pedestrian component. LCMC members stated improvements can be made by connecting trails, improving trail etiquette, enforcing existing rules, ensuring seniors and people with disabilities have enough time to cross the street, and ensuring there are walkable destinations. LCMC members recommended NFRMPO staff attend Transportation Boards and local senior advisory boards.


