  - Gary provided an update from DARTAC: In 2016, Transfort had more than 4
     Million riders, including 1.4 Million on MAX. Dial-a-Ride saw a small decrease in rides given. LCMC asked if Dial-a-Taxi is taking pressure off of Dial-a-Ride.

#### 5. Action Items

 Elections – Angela Woodall was nominated to be Chair and Ruth Fletcher-Carter was nominated to be Co-Chair. Toni made a motion to approve, and Katy seconded the motion. The motion was passed unanimously.

#### 6. Discussion Items

2017 Coordinated Plan – Alex passed out updated draft demographic maps, a summary of previous identified issues and goals, and an outreach schedule. Identified issues to be further discussed included the lack of funding, the lack of transportation between urban areas, additional research into advocacy versus lobbying, and to ensure the goals are measurable and obtainable. NFRMPO staff will study PUC requirements as well. LCMC members suggested groups to reach out to for outreach, including the Larimer County Office on Aging, the local Transportation Boards, Senior Transportation Coalition, and the Berthoud Town Trustees. NFRMPO staff should add activity centers at subsidized housing, housing authorities, Habitat for Humanity housing, veterans/VFWs, doctors' offices, senior centers, medical centers, ARC, Goodwill, wellness centers, and community centers. Alex will bring this information back at the April meeting for further discussion. He will begin the draft chapter and bring it to April as well.

Senior Transportation Update – Katy stated the study for senior transportation needs is underway for rural/unincorporated Larimer County. The County will hold senior focus groups throughout the County: Estes Park, Berthoud, and Laporte. The Study will also look at best practices for seniors and people with disabilities. Peer groups include: Marin County, CA; Arapahoe County, CO; and Douglas County, CO. Additionally, the Study will look at technology, including the Liberty App and ITN Country. The County sent out 1,500 surveys and had a 34 percent return rate. The Study is set to be completed by June 30<sup>th</sup>.


- o Ruth Fletcher-Carter RAFT is above the number of rides they expected to give.
