Discussion Items

LARIMER COUNTY SENIOR TRANSPORT STUDY	The Larimer County Senior Transportation Needs Report subcommittee is working on a proposal for the Larimer County Board of County Commissioners, which is due in November. A visual map showing transportation in Larimer County was produced. Suzette Mallette, Larimer County Transportation Program Manager, will be meeting with TriCounty Health from the Western Slope to discuss the Liberty Mobility program. Ruth said she will be talking with someone from Spearfish, SD, and asking questions related to the senior study. The group is aiming to bring a recommendation to the group in December. Anna offered to help with travel training.
OUTREACH TEAM	A calendar was passed out to show the events Alex received from STC members. Anna explained the Fort Collins Senior Center is holding an Older Driver Awareness week in December and passed out a calendar for people to sign up for staffing the booth. Items to be included were: Bustang brochures, Transfort information, Rider's Guides, Older Driver Reports, and Office on Aging Guides.
