Transportation is a major source of air pollutants like ozone and carbon monoxide. The NFRMPO is responsible for meeting state and national air quality standards.



### Mobility Coordination

Connecting the region with a bicycle and pedestrian trail system.



### Freight Planning

Planning for the transportation of goods through and across the region.

Connecting the region through public transportation and vanpooling services.

Reducing the amount of time vehicles spend on the road.

Human service and transit agencies advising on regional mobility coordination

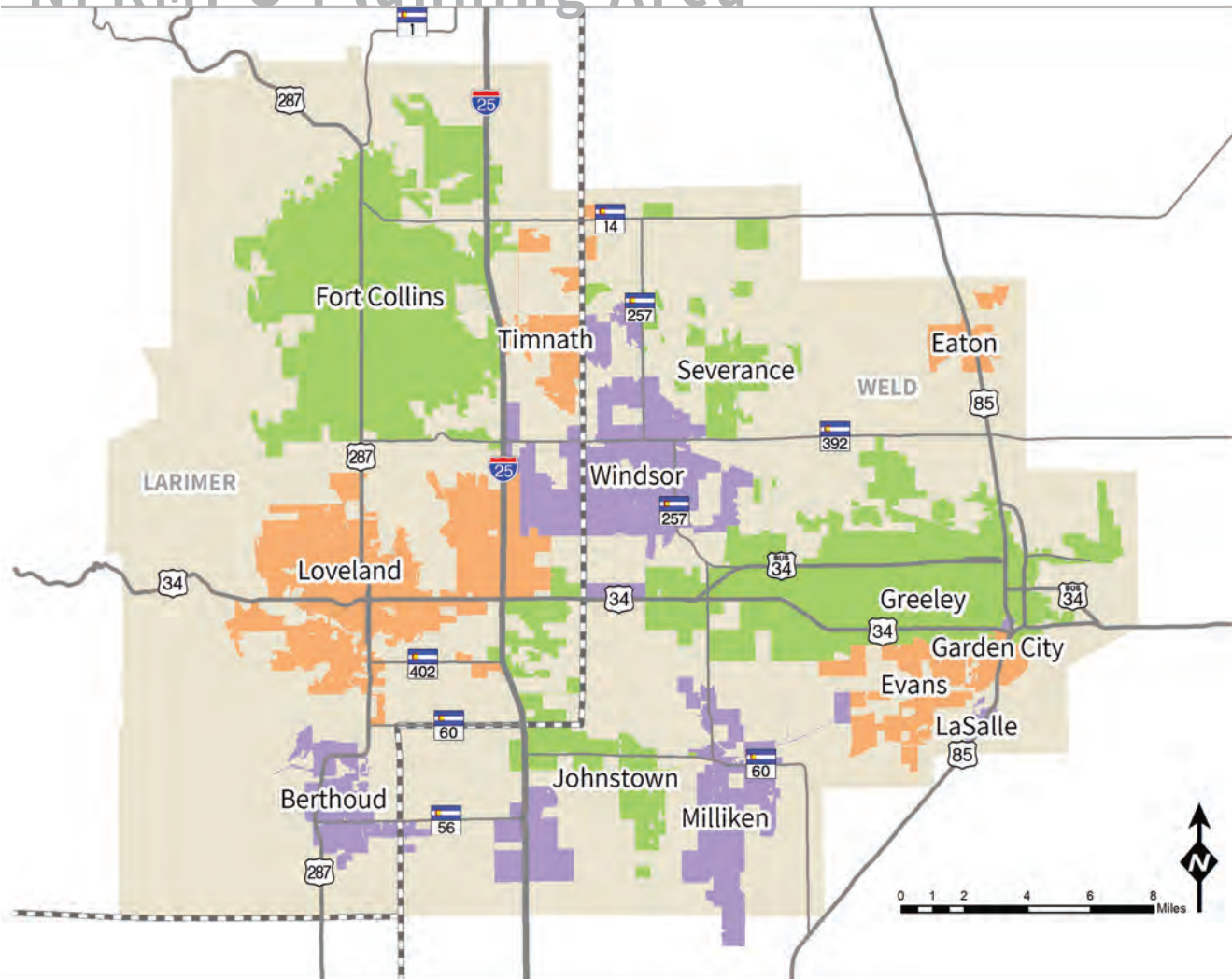
### NFRMPO Staff

## NFRMPO Planning Area



### Unified Planning Work Program (UPWP)

Identifies the transportation planning tasks to be completed over the next two years.



### Regional Transportation Plan (RTP)

Sets a 20-year vision for the region's transportation system.



### Transportation Improvement Program (TIP)

Lists all surface transportation projects funded with Federal dollars and all regionally significant transportation projects funded with State and Local dollars.
