Discussion Items

ONE CALL/ONE CLICK CENTER	<p>Alex provided an update on the OCOCC project: the NFRMPO applied for funding from the CDOT Consolidated Capital Call for Projects (CCCP) for the One Call/One Click Center project, specifically for the trip discovery software. The NFRMPO is waiting for CDOT on contracting for the MMOF funds, which will be used to hire the Mobility Manager hopefully by the summer. NFRMPO staff are working on a draft Mobility Manager job description. Ruth requested a providers meeting to focus on customer service and provider standards. Alex also reported there was a meeting with Larimer County and Weld County senior transportation groups, and they were positive. The project will be regional.</p>
OUTREACH	<p>Anna was able to get the MAPG/STC a booth at the Wellness and Retirement Expo being held at the Fort Collins Senior Center. Alex and Brooke are working with the Family Center and Community Champions on Spanish Travel Trainings. CDOT has given permission to use the Bustang bus if needed. The group discussed the AARP Livable Communities Grant opportunity due in April. PAFC is looking for projects to support. The group mentioned adding travel training and bicycle education to an Open Streets event. The idea will be taken to the PAFC Steering Committee.</p>
MMOF PROJECTS	<p>Alex stated NFRMPO had a Call for Projects for the Multimodal Options Fund (MMOF), which were bicycle and pedestrian or transit projects that benefitted older adults and safe routes to school. Thirteen projects were awarded funding through the Call with two NFRMPO-led projects receiving a set aside. Relevant projects were a sidewalk connecting to the future Loveland North Transfer Center, new sidewalks in Berthoud, and new buses and design for the West Elizabeth BRT in Fort Collins. The projects still need to be approved by the NFRMPO Planning Council at their April meeting.</p>
