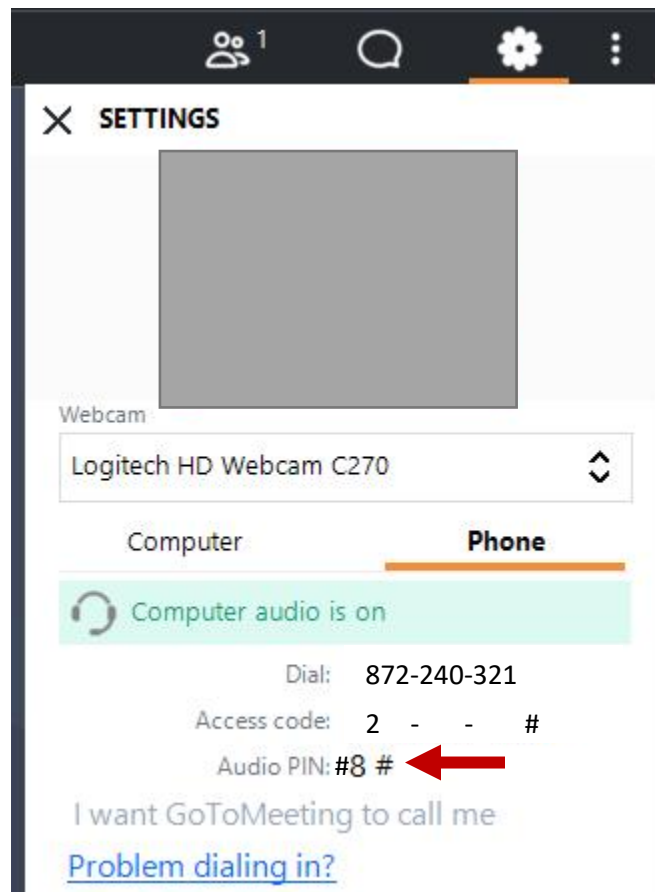
## Remote Attendee Instructions

## Monthly Report from the Air Pollution Control Division to the North Front Range Transportation and Air Quality Planning Council Thursday, October 1, 2020

### Air Pollution Control Division (Division) Updates:

### September 17, 18, and 23, 2020 Air Quality Control Commission (Commission) Meeting:

- In response to the COVID-19 pandemic, all Commission meetings, prehearing conferences, and status conferences will be held as remote meetings only. This will continue until further notice. Additional information and updates and all meeting documents are posted on [www.colorado.gov/pacific/cdphe/aqcc](http://www.colorado.gov/pacific/cdphe/aqcc).
- The Commission approved new rules to improve monitoring at oil and gas sites and reduce emissions of ozone precursors. The rules require oil and gas operators to monitor emissions during pre-production activities. The rules requires operators to report carbon dioxide and nitrous oxide emissions. The rules also set emissions standards for natural-gas fired reciprocating internal combustion engines equal to or greater to 1,000 horsepower.

### September 25, 2020 Commission GHG Strategy Subcommittee Meeting:

- The Division provided a briefing regarding focus group discussions with members of disproportionately impacted communities.

### Upcoming October 22 & 23, 2020 Commission Meeting:

- The October 22 & 23 Commission meeting will include the following agenda items:
  - The Commission Administrator will present the final draft of the Annual Report to the Public. The Commission will provide opportunity for public comment.



- Representatives from National Jewish will provide information regarding COVID-19 and possible links to ambient air quality.
- The Division will present the 2020 ozone monitoring data and report on any exceedances or violations of the current ozone standard.
- The Division, National Park Service, and the EPA will update the Commission regarding the Rocky Mountain Park Initiative, data trends, and progress in achieving milestones.
- The Division will provide a briefing on the development of guidance in reference to the Clean Energy Plan under HB19-236.
- The Colorado Energy Office and consultant, Energy and Environmental Economics will present the Greenhouse Gas Roadmap. A public comment session will be held.
